# **Continuing Medical Education**

## **2023 ANNUAL REPORT**

Licking Memorial Hospital (LMH) has been providing continuing medical education for physicians since 1975. On April 21, 2022, LMH received accreditation with commendation, effective through April 21, 2028. All educational activities were approved for *AMA PRA Category 1 credit™*. In 2023, five regularly scheduled series (RSS) were provided, including 39 Monday Noon CME conferences, 41 Multidisciplinary Cancer Case conferences (Tumor Board), five Anesthesia Department CME conferences, six Hereditary Genetics Cancer conferences, seven ICU Mortality, Morbidity, and Improvement conferences. In addition to the RSS activities, six single live activities were offered "Continuous Renal Replacement Therapy (CRRT) Training" with Udayan Bhatt, M.D., OSUWMC, "TPN in the Critically Ill" with Oluwatoyin Aduloju-Odunaiya; "Prevention of Central Line-Associated Bloodstream Infections (CLABSI)", conference with Rachel DeMita, M.D., "Neonatology Transport Case Review Conference" with Christopher Timan, M.D., "Common Epilepsy Syndrome" conference with Neil Kulkarni, M.D., and "Updates on Chest Pain Guidelines and Cardiac CT" with Blair Sutter, M.D., OSUWMC. Participants had the opportunity to attend 37 LMH Virtual Watch Parties featuring OSU MedNet 21 webcasts. The Monday Noon CME conferences and Multidisciplinary Cancer Case Review (Tumor Board) conferences were approved for credit by the American Academy of Family Physicians. Conferences were attended both in-person and virtually via Microsoft Teams.

A total of 104.5 individual CME activities were presented with 104.5 AMA PRA Category 1 credits™ provided by the LMH CME program. There was a total of 37 AMA PRA Category 1 credits™ provided by The Ohio State University (OSU) through MedNet21 programs. Combined participant attendance at live activates totaled 3,020 learners for the year. Participation decreased by 922 participants in comparison to 2023. The five activities having the best attendance were "Congestive Heart Failure" with Vaibhav Patel, M.D., The Ohio State University Wexner Medical Center; "Updates on Chest Pain Guidelines and Cardiac CT" with Blair Sutter, M.D., The Ohio State University Wexner Medical Center; "LMH Quality Comparisons, Technological Advances and Upcoming Initiatives" with Robert Montagnese, CEO and President LMH; "Dos and Don'ts of Physicians Documentation" with Natalie Brown, Esq, Assistant Vice President Legal Services and Beau Richesson, LM Quality Manager; and "Cultural Humility – Part II" with James Knight, PhD.

### **Annual Program Improvements**

#### Survey Monkey Evaluations

To ensure that providing feedback and obtaining CME credits for completed educational activities is convenient, the Medical Education and Library Committee approved the use of Survey Monkey, to create activity evaluations. Learners now have the option to access and complete the evaluation through a Survey Monkey link located in the Microsoft calendar invites or activity reminders. Participants still may complete paper evaluations if attending conferences in person.

#### DocuSign Planning

To streamline planning CME activities and obtain the necessary documents, the Medical Education and Library Committee approved utilizing the DocuSign program. DocuSign has allowed us to streamline the process of getting documents signed and routing documents through a review and approval cycle. This has reduced the administrative burden on presenters and planners, and allows for the process to be electronic.

#### LMH CME Website

The LMH CME websites login and password are no longer required and have been removed. Learners can now access the CME website link: <a href="https://www.lmhealth.org/Community/Continuing-Medical-Education">https://www.lmhealth.org/Community/Continuing-Medical-Education</a>, and will be taken directly to the "About Us" page. Learners can navigate the website by selecting the desired tabs located at the top of the screen. The website offers "Self-Study" modules made from recordings of past Monday Noon CME conferences, Podcasts, and Webcasts. The "Physicians Patient Care Resources" page and an "Upcoming Education" page hold information on all the months upcoming CME activities.

#### **Self-Study Materials**

Self-study modules were created from live recordings from the 2023 "Monday Noon CME" conferences. Participants can visit https://www.lmhealth.org/Community/Continuing-Medical-Education, and then access the "Self-Study Modules" tab to watch the recording and access resources for continued study. To obtain CME credits for completed modules, learners must complete the survey monkey evaluation and posttest activity.

### **UpToDate**

Learners can earn CME and Maintenance of Certification (MOC) credits for reading articles by using UpToDate. UpToDate can be accessed by providers on their desktops, through the Epic toolbar, the Employee Portal under Quick Links/Medical Staff Resources or by utilizing the UpToDate mobile app. To earn credits learners must create a login and password (under the Licking Memorial Hospital hub) to receive credit for completed articles.

#### **Annual Goal**

The Medical Education and Library Committee's annual goal for 2023 was to provide an online library to providers that would be hosted on the LMH CME website. However, due to hosting issues this goal was not able to be accomplished. In 2024, the Committee plans to provide a physical selection of physician recommended books that learners can check out for a month at a time and read free of charge.

#### **LMH Medical Education Planning Committee Members**

Committee members work hard to plan education that will enhance a providers practice, and are designed to change competency, performance and improve patient outcomes. This Committee is made up of multi-disciplinary providers and has expanded its membership to include inter-professional planning partners.
